Atlanta Swing Classic Liability Waiver and Refund Policy

By purchasing a ticket to the Atlanta Swing Classic (“the Event”), you are also electronically signing, or will physically execute this Liability Waiver and Refund Policy (“The Waiver and Refund Policy”). The Waiver and Refund Policy is nothing out of the ordinary, and is standard for any event you have attended in the past, it is just stating that you are responsible for the care of yourself, and are responsible for yourself if you do something silly or injure yourself; or injure another person attending the Event. Everyone who has paid to attend the Event has signed electronically by purchasing online, and/or must have done so to enter the Event. The Waiver and Refund Policy

1. I acknowledge and understand that all fees (weekend pass, contests, and all extras) related to the Event are non-refundable. They may be transferred or sold to another person before October 13, 2019. They hold no value after October 13, 2019.
2. I acknowledge that my attendance and/or participation in the Event is voluntary and involves the possibility of physical injury, disability, death, and/or damage to myself and to others.
3. I HEREBY VOLUNTARILY ASSUME THE RISKS OF ATTENDING AND/OR PARTICIPATING IN ANY ACTIVITY AT OR ASSOCIATED WITH THE EVENT.
4. In consideration of the all entities allowing me to use and/or participate in the Event, I hereby state the following:
 - a. I WAIVE, RELEASE, AND DISCHARGE Atlanta Swing Classic, The Atlanta Swing Dancers Club, Inc. and/or any of its agents, the Facility and/ or any agents at which the Event is held, and any other entities that help support the Event from any and all claims, losses, or liabilities for death, personal injury, partial or permanent disability, property damage, medical or hospital bills, theft, or damage of any kind, including economic losses, which may arise by reason of my participation and/or presence at the Event. To the extent possible by law, I hereby fully waive, release, and discharge all parties notwithstanding their own negligent acts or omissions or the negligent acts or omissions of others.
 - b. I agree that I will not bring any action or claim against any of the parties hereby released for any reason associated with the Event.
 - c. I INDEMNIFY AND HOLD HARMLESS the parties hereby released from any and all claims made or liabilities assessed against them as a result of my participation in the Event and/or usage of the Westin Hotel or it’s associated facilities.
 - d. I ACKNOWLEDGE AND ALLOW the use of any and all voice recordings, photographs and video taken of me at the Event to be used by Atlanta Swing Classic and Atlanta Swing Dance Club, Inc. for any promotional purposes or any other uses without further consent or notification.
